### Flora Grange News January 2021

The January 2021 meeting of Flora Grange was held as a free conference call with some 15 members. This form of meeting was held due to the COVID-19 pandemic of social distancing, wearing of masks and a limit of participants when meetings are held.

Jack Ratcliffe welcomed members and conducted the meeting, followed by Chaplain Emalee Colver offering a prayer including concerns for our country as well as our Flora Grange membership. Secretary, Laurel Ratcliffe read the minutes of the last official meeting of October 2020, and they were accepted as written.

Buildings and Grounds chairman Jack Ratcliffe reported the settings of the heat on the furnaces has been lower, and some of the refrigerators have been unplugged, as they are not beings used at this time, which lowered our electric bill some \$50 this last month.

Ratcliffe also reported the Boone County Fair gave Flora Grange \$15 for each member (131), totaling \$1965.00, which will cover the cost of our membership dues for the first quarter to the Illinois State Grange.

Secretary Laurel Ratcliffe sent out thank you notes to the seventeen individuals that gave memorial gifts in memory of Theo Hildebrand, age 102, an 80-year member of Flora Grange that passed away on December 7, 2020.

Deb Silvers reported on Hometown Christmas. She stated that due to the pandemic everything was virtual, therefore their Christmas tree was left outside the family's home as well as the ornaments which were made by the committee members and the Flora Grange quilters group. Laurel reported that the Hometown Christmas drive thru at the Park District had set up was quite receptive and Flora Grange participated with a display wishing season greetings to the viewers.

Emalee Colver reported the quilter's group has gotten so large that it needed to be divided and due to the icy conditions at the Flora Grange hall, the next quilting session would be held at her home.

Laurel Ratcliffe stated that the Community Service Book for last year received 3rd place but as of yet, no monetary recognition has been received. Laurel also stated that Flora Grange's booklets are available, and she will be distributing them as fast as she can. There will be some at quilting for those individuals to pick up. Please let her know that you received one.

Chaplain Emalee Colver gave a report on whom she sent get well and sympathy cards to, and Flora Grange lost another member, Craig Woosley.

Jack Ratcliffe and Robert Scherer reported on the Boone County Fair, and stated they are preparing contracts and contacting participants for entertainment for the 2021 fair. Jack announced there will be a Draft Horse event in June conducted by the Hagemanns. There will be a fair board meeting on January 26th for fair board members only.

#### **New Business:**

Dinner: Flora Grange has set the date of April 11, 2021 for a roast beef dinner at the Flora Grange Hall, and at this time we do not know if it will be set-down or drive-thru dinner. More details will be shared as the time gets closer.

Treasurer Lindakay Ebel received an annual statement from the Belvidere Chamber of Commerce for our 2021 dues. A motion was made that Flora Grange join the chamber again this year and she pay the statement, motion carried.

Kathy Spears spoke about the Girl Scouts cookie sale and how the COVID-19 has affected the sales. Discussion of suggestions of how to secure orders was held. It was suggested that Laurel include the cookie sale information in Flora Grange newsletter.

The meeting was adjourned due to time limitations, and everyone was thanked for being a part of it, and it is hoped to have a real meeting in February at the Flora Grange Hall.

Ingredients:

1 pkg cranberries, chopped

(Mother used an old-fashioned food grinder, I use a food processer.)

2 cups sugar

STIR TOGETHER and let sit all day, overnight, or until sugar is melted.

MIX IN

2 cups mini-marshmallows

2 cups pecans, chopped

2 Delicious apples, chopped fine 1 pint whipping cream whipped

**FREEZE** 

Use as a dessert, a sweet salad or a side dish.

## 2018 Farm Bill Explained: Part 2

As we dive deeper into the 2018 Farm Bill- this month we will be taking a look at the area that encompasses the largest amount of the Farm Bill. This area is known as Nutrition.

This Title of the Farm Bill reauthorizes numerous Nutrition and Domestic Food Assistance programs that are used throughout the Country.

The programs that were reauthorized in 2018 are as Follows, and these programs have been reauthorized until September 30th, 2023.

SNAP and related grant programs (e.g., SNAP Employment & Training)- forming known as Food Stamps

Programs in lieu of SNAP: Food Distribution Program on Indian Reservations (FDPIR), grants for certain territories

The Emergency Food Assistance Program (TEFAP)

Commodity Supplemental Food Program (CSFP)

Community Food Projects

Senior Farmers' Market Nutrition Program (SFMNP)- also known as Farm Market WIC checks

Food Insecurity Nutrition Incentive (FINI) grants.

Of these Programs SNAP is the largest one, utilizing the most of the funding for the Nutrition Section of the Farm Bill. 95% of SNAP spending is actually used for the benefits themselves which are 100% federally funded. Since SNAP is federally funded, amending the eligibility, benefits and other program rules can have a budgetary impact. At the same time the availability of appropriated funding can also affect the operation of SNAP and SNAP Ed. The amount of spending in SNAP is driven by participation in the program, which can change at any given moment due to economic conditions and program rules. 2020 has seen an uptick in SNAP usage largely due in part of the Covoid-29 Pandemic.

The Emergency Food Assistance Program (TEFAP) was developed to help supplement the diets of low-income Americans by providing them with emergency food assistance at no cost. USDA provides 100% American-grown USDA Foods and administrative funds to states to operate TEFAP.

The Commodity Supplemental Food Program (CSFP) goal is to help improve the health of low-income persons who are at least 60 years of age by helping them add nutritious USDA Foods. The USDA distributes both the food and the administrative funds needed to all participating states and Indian Tribal Organizations.

The Community Food Projects (CFP) competitive grants program awards grants to eligible nonprofits, tribal organizations, and food program service providers to promote self-sufficiency and increase food security in low-income communities by developing comprehensive, community-based solutions.

At our 2019 State Session, a resolution was discussed dealing with Farm Market WIC checks, as you can see, SFMNP (Senior Farmers' Market Nutrition Program) is one of the program funded in the Nutrition Title of the Farm Bill. The goal of SFMNP is to provide funds for Senior Citizens to use on Fresh Fruits and Vegetables at Farmers Market. This does a couple things, supports our local farmers, and gives our low income Senior Citizens the

availability to purchase fresh fruits and veggies.

The Food Insecurity Nutrition Incentives (FINI) Program provides grants on a competitive basis to projects that help low-income consumers participating in the Supplemental Nutrition Assistance Program (SNAP) purchase more fresh fruits and vegetables through cash incentives that increase their purchasing power at locations like farmers markets. Some of us know this Program as LINK Up or LINK Match. These can be seen at Farmers Market that accept SNAP benefits. Usually most produce found at a Local Farmers Market maybe higher price than a regular grocery store. This Link Up/Link Match grants allows Farmers Markets to match a certain amount of snap funds. So, if a person wants to spend \$10 of SNAP funds at a market, that market may be able to match that \$10 allowing that customer \$20 to spend instead of \$10.

As you can see feeding our citizens is a priority and always has been a priority of the American Farmer. This is why the Nutrition Title makes up a huge portion of the farm bill.

## Mary Beth Lee 2020 Community Service Granger of the Year

As adapted from Turkey Hill Grange's Nomination of Mary Beth Lee for Community Service Granger of the Year.

Looking for a member who eats, lives and breathes Grange? Look no further than Mary Beth Lee. Essentially, her entire life has been connected to the Grange, but since this nomination is to be based only on her involvement this past year - there is still plenty to share.

At the start of this year, after observing the impact of the Quilts of Valor, Mary Beth immediately volunteered to involve her Grange and its members in the program. Through motivation and excitement, she almost instantly recruited six-member quilters to assist. As a result of her love of Country and its Armed Forces, 12 quilts were made. (At the time of nomination, the delivery has been delayed due to COVID-19).

Early in the year, her Grange's membership team leader became ill and was unable to carry out the recognition of long-time members and our community citizens, leaving a great membership recognition program and dinner in danger of being cancelled. As soon as Mary Beth heard of the situation, she sprang into action. She contacted the Grange Secretary to learn of the individuals who should be recognized and, on short notice, contacted a caterer to prepare an impressive dinner rather than trying to convince some members to organize a less impressive potluck meal. To have a greater impact on our area, the caterer whom she obtained was a Church that donates all the proceeds of the dinner to children's missionary work in the US and Central America. (At the time of nomination, the delivery has been delayed due to COVID-19).

Come dues paying time at the beginning of 2020, dues paying was unusually slow. Mary Beth contacted the secretary requesting the names of those who had not paid their dues after two months. She contacted some dozen families about their value to Grange and why their dues were needed. As a result, all delinquent dues were collected. She also obtained many corrections to the membership roster, such as phone numbers, email, and mailing addresses.

Due to COVID-19, all major fundraising activities were cancelled. One of those caught Mary Beth's attention, so she quickly concluded that a quilt raffle could be conducted by delaying the date of the raffle. This raffle is but one of the ways she has inspired members to participate in fundraising activities by her active involvement and excitement about the potential use of the proceeds to improve her community. She was always the first to volunteer for that job, shunned by many members such as being a cashier and ticket taker. Her efforts during her Grange's Thursday afternoon summer BBQ in late 2019 was especially noteworthy. Anytime she worked, meals were processed and delivered in about one-half the normal time.

When it was time for the annual election of officers, Mary Beth asked if she could be her Grange's Chaplain. Of course, she was elected without question. In that position, she personally has contacted all members who are sick or hospitalized as well as sending them cards of sympathy. As Chaplain, her prayers are original, personable, and timely rather than the standard printed prayer used by many. Additionally, she interjects appropriate moral and ethical suggestions in meetings – especially when issues pertaining to members are being discussed.

Being a long time Grange member, Mary Beth was a stabilizing member of Turkey HIll's Executive Board this past year on Grange issues. She made tactful and compassionate comments concerning the reason certain procedures are employed and practiced. She is on hundred percent support of the Grange at all levels.

As a registered nurse, she assists neighbors with medical issues, especially during the COVID-19 conditionals. Her actions in this

capacity have been a calming influence to many neighbors. Additionally, she is an active member of her community's Neighborhood Watch Program - in a specific case, she notified a neighbor of a suspicious moving van in the areas - eliminating a potential burglary.

Mary Beth is most active in her church - a leader in the church's women's activities and an advocate for supporting a children's home and nearby

community's group providing assistance to less fortunate families in the area. She is also a supporter and participant in her church's sack lunch program to serve the area's homeless and disadvantaged.

It is difficult to find a Granger that has made more contributions to the Grange than Mary Beth Lee during the past 12 months. She has definitely earned and deserves the title of Granger of the Year for the Illinois State Grange.


When I was three years of age, I first met Theo Hildebrand, a kind-hearted, loving, caring lady who I loved the first time I met her. No, it was not because she gave me several of her delicious homemade sugar cookies she was baking, there was just something special about her that other friends of my mother's did not seem to have.

Theo would ask my Mom to drop me off at her farm when my Mom was going shopping, or when she had to help my Dad in the field all day, and I was delighted. Yes, we lived on a farm, on the corner of Irene and Cherry Valley Road, and Theo and her husband, Ralph lived on their family farm not too far away on Stone Quarry Road.
