Secretary Minutes 1st day of the 153rd Annual Session of the Illinois State Grange September 13, 2024

Presession Activities

The display room was opened at 8:00AM to check in contest entries in the Agriculture, Family Activities, Lecturer, Junior, Community Service and Youth Department.

At 10:00AM the Illinois State Grange Officers practiced for the opening drill and the Sixth Degree.

At 1:00PM the first day of the 153rd annual session of the Illinois State Grange was called to order by President Lynette Schaeffer in the Sixth Degree at Doubletree Hotel in Collinsville, IL.

Brother Justin Schaeffer moved to adopt the Order of Business for the 153rd annual session of the Illinois State Grange as amended, and Brother Don Ellwanger seconded the motion. Motion carried. The full Order of Business will appear in the journal.

Sister Ruth Blasingame President of the Boone County Pomona Grange invited everyone to come to the 154th annual session of the Illinois State Grange which will be September 19-21, 2025 at the Boone County fairgrounds Belvidere, IL with Boone County Granges serving as hosts.

Sister Lynette Schaeffer invited everyone to come to the 155th annual session of the Illinois State Grange at Northfield Inn and Suites in Springfield, IL, date to be determined.

Reports were given by the following:

Treasurer – Mary Donley - a copy of the proposed budget is in your Delegate books, She also gave a listing of all accounts. Discussion followed: The closed Grange accounts have been put into CD's; unclaimed funds have been recovered from the Illinois State Treasury. A discussion followed on the possibility of dues increase and mileage reimbursement decrease to balance out the income and expenses of the fiscal year.

Marilyn Coe moved to approve the Executive Committee summary report as amended and Carol Neff seconded the motion. Motion carried. The nominations for the 3-year term of the Illinois State Grange Executive Committee member took place and Deb Wade of Hopewell Grange was reelected for a 3-year term on the Illinois State Grange Executive Committee. Congratulations Deb!

Following the meeting Special Guest Charles Meier Illinois State Representative from the 109th District was our guest speaker. He gave a brief history of his life living on a farm and being involved in Agriculture. He stressed Farming is the backbone of America. He talked about the inheritance Bill that will affect the local farm family and he talked about Carbon emission project. Charlie is a very strong supporter of 4-H program and Agriculture classes in Illinois.

We need to keep our family farms going. Sister Lynette thanked Charlie for coming and speaking to us and she thanked Ken Hartman from the National Corn Growers Association for joining us as well.

Red flags: are buy – sell – trade pages, commenting is turned off, Past tense used or odd grammar. Pictures that tug at your heart strings.

Brother Phil gave us ways to be safe. Always be skeptical, check URL address be sure you are being safe. Never send money to someone you don't know and never share passwords.

If you think you have been scammed here are things to do about it. Cut communications with that person. Document everything. Report the scammers to BBB, FBI and police. Monitor your accounts if affected stop them and change passwords. AARP Fraud Network will help seniors. The phone number is 877-908-3360.

Don't take surveys online, don't do Quizzes online and don't do surveys with 30 questions. Be sure to keep yourself safe when online. Sister Lynette Schaeffer thanked brother Phil for presenting his workshop.

Credentials Report 2023 - 2024

When the quarter ended June 30, 2024, the membership of the Subordinate Granges of Illinois was 703 members. This breaks down to 558 individuals with 36 family plans that included 132 family members, and 15 associate members. Illinois has 95 Golden Sheaf members in which 13 received the Golden Sheaf Award prior to January 1, 2001. 8 Subordinate Granges have a total of 29 affiliate members. There are 3 Pomona Granges in Illinois with a total of 206 members.

Illinois has 7 Granges with Junior Grange Charters (Emerald Mound, Enterprise, Flora, Hopewell, Prairie, Turkey Hill, and Shiloh Valley) and about **20** Junior Grange members and 11 Junior +1 members.

During the past membership year (July 1, 2023, to June 30, 2024) there were 6 members who reached 50- years of membership, and 2 members received the 75-year Diamond Award.

Additional milestones: 9-25-year Silver Star Certificates, 11-30-year seals, 2-35-year seals, 5-40-year seals, 4-45 year seals, 1-55 year seals, 0-60 year seals, 1-65 year seals, and 1-70 year seals were presented. It covers topics from where bank accounts are located and what kind of care you're willing to have, to who in your community might be able to help you with certain activities post-surgery." Find information at National Grange or contact me, I have limited information to share. And the Rural Life Initiative that IL is a pilot state. National Grange has much health care information to share that can be printed and shared by our Granges. National Grange is in partnership with Rural Minds [ruralminds.org]. Jeff Winton, is the founder whose mission "is to serve as the informed voice for mental health in rural America, and to provide mental health information and resources."

Shortly after Don and I were married, now I was a River Rat that means I was raised in the bottoms (flat land no hills) next to the Mississippi River and I married a so called hillbilly meaning Don came with land that had hills on it. That fall was a rainy one and since I came from the farm I was put to work to help since I didn't have an off the farm job yet. We were busy picking corn (a pull along picker with the tractor) with those hills coming up now I know that the at the bottom of that hill the ground was going to be wet. So I was told to go to the top of the hill and wait to make sure he could make it up the hill without getting stuck. Well, that was not going to happen, like many other farm wife's do we listen to our husbands so to the top of the hill I go. I wait for him to start coming up the hill now and sure enough he gets stuck (tractor, picker, and half a wagon full of corn are not going to make it up the hill by its self so I back half way down the hill set the brakes on my tractor get the log chains off my tractor and hook them on to the tractor Don is on. I get back on to the tractor I'm on release the brakes and slow but surely start up the hill I'm not going fast enough to get up the hill so I give it more gas only to have the front end comes up off the ground, hands crossed. Feet crossed and anything else I could have found to cross at that time and remember God raised me to be a river rat not a hillbilly. We finally make it to the top of the hill front of tractor back on the ground and I can unhook the chains and turn around so I can be on the other side of the hill to do the same job over again.

Now I know that you are all sitting here wondering why I bore you this morning but there is a reason for you see once I got used to those little hills they weren't that big anymore because I learned to put my truth in the Lord like so many of us do, but coming to a different kind of farm land. We all think of the worst things in our minds which is the way to be. Do you ever think just the greatest things will happen right away and not worry about. We do not trust enough in the Lord that we worry long before it even happens. Over the years those big hills are small compared to some of the hills and mountains I've been on, we call it faith and preserves for the Lord is with us always.

HISTORIAN "SHOW AND TELL" PRESENTATION AT STATE GRANGE SESSION SEPTEMBER 14, 2024

Hello Patrons! You can read my annual report on pages 26 and 27 of your booklets. I hope you got an opportunity to look at my display in the display room. The South Granges book will show many of the St. Clair County Granges of the past. The State Grange book shows many state sessions of the past. The newest book I have made is Rock River Grange#1921. Dorothy Newcomer (who passed away this year) donated many items to me so that I could highlight their active years in a separate book.

Just to let you all know, I have about 44 notebooks, 15 collections and at least 10 tubs of Grange memorabilia. Some of the collections include: Grange booklets, pamphlets, bumper stickers, membership forms, By-laws, songbooks, cookbooks, Declaration of Purpose, Rosters, Journals of State Sessions, jewelry, Grange books, Granger newspapers, the 1967 Grange stamp, and lots of other Grange miscellaneous items.

I visited the Boone County Fair this August and spoke with Kim. The Grange Museum is not set up yet but offered my help when they start setting it up.

I was glad to hear from some of the other Grangers that they also check on E-bay for Grange items. I narrowed the search for Illinois Grange items. Did you know the Illinois State Grange held State Session in another state? Yes, here is the program booklet from the 75th session held in Hotel Statler in St. Louis, Missouri from October 16-19, 1946. In past years State sessions could be held in December, October, September and more recently August. This session we worked on updating the By-Laws. I found this By-Laws booklet from December 10-12, 1929 session held in Oregon, Illinois. Then I found these two National Grange booklets (about 1949) titled "The Farmer's Best Friend"—useful information on the farm, and why you need the Grange.

The oldest item I found was an officer badge ribbon in its original envelope from Orange Grange #843. I believe it to be the Flag Bearer because of the American flags on the top. The seller also sent me a small book of their handwritten By-laws when organizing on January 10, 1874. Gary Hecathorn also has some of their record books and stores them in Hopewell Grange archives.

Another item I purchased was the 69th Illinois State Grange session Journal of Proceedings held in Rockford, Illinois December 10-12, 1940. Back then each Grange made an annual report to be published in the journal. There were 85 Subordinate Granges represented by 145 delegates and 11 Pomona Granges represented by 22 delegates. So, I thumbed through the booklet but was really surprised on the very last page. It was the report by Guilford Hope Juvenile Grange#22. The Master was Harold McLarty (my uncle) and Secretary Alice McLarty (my mother). It certainly touched my heart!

I truly love being the Illinois State Grange Historian and I thank you for the opportunity.

Pride is an understatement in describing my feelings about this. I know how hard the seven Granges of Boone County worked to put on one of the largest fairs in the state of Illinois and definitely the best in our area. As hard as we work to put on the fair we need to work equally as hard throughout the year on our Granges. They are the reason why our fair exists. As I see other counties throughout the state give up on their county fair because of politics and money, our "little" fair trudges on, because over 60 years ago the Members of Boone County Pomona Grange made the courageous decision to take over the running of the local fair, and created a Fair board made up of Grangers from every Grange. Then seeing that the area where the fair was being held would not accommodate much growth chose to mortgage their farms, houses, businesses to give money to the Pomona Grange to purchase the first plot of land and began adding buildings, barns, a grandstand, harness racing track, and so much more. This did not happen overnight, and improvements are still being made every year. Our fair shows how much influence the Grange should have in our community, yet if you ask someone who owns our fair, they are more than likely going to tell you the County Board. We have signs and billboards up throughout the Fairgrounds showing who owns the Fairgrounds, yet people do not believe that it is privately owned. Throughout the year our Granges are seen working hard on Community Service through their actions supporting 4-H with dinners, doing the food at major community events, sponsoring meals for the holiday dinners the food bank give out, and so much more, yet if you ask members of our community who we are they don't know until one of us says, the Granges of Boone County own and operate the Boone County Fair. Then a glimmer of knowledge sparkles in their eyes and they comment "isn't that where they have those big craft shows, I love going to those." What are we doing wrong that they remember someone who rents our grounds and not us?

I feel that this problem is happening throughout the state, with a few exceptions. Hopewell Grange did an excellent job at helping their community after the tornado a few years ago. But then Covid happened, and we are all still trying to recover. Covid did, in some instances, show people that they want to be involved in something, they want a place to belong. How do we make our meeting the one everyone attends each month? How do we make our Granges name, the name on everyone's tongue? We need to become the people our founders over 150 years ago were. We need to get our name out there and make people want to be part of our organization. How do we accomplish this? We need to work together to figure it out. We need to stop being our own worst enemy and invite people in.

I have spent the year attending most of my Prairie Grange meetings where I serve as Secretary. Luckily the couple of times I have missed I have a great support system in place to help me out. I am on the Grange Revival planning team and the National Grange Session Work Advisory Group. The work advisory group presented our proposals for change to the National Grange members last year focusing on remembering that National Session is for those wearing blue sashes not those wearing gold sashes. I was just asked to be on Community Grange Focused Forward Group searching for the best ways to get information from National to the local level. I am also in charge of Tours and Transportation on the planning committee for the 158th National Grange Session in the Quad Cities.

These 4 groups, my Grange and work take up the bulk of my time, however Youth Co-chair Marisa Odell and I have hosted Spring Fling with many Youth and Juniors in attendance and various adults coming throughout the weekend. On Friday night we had a movie night and played games. We had a

great time getting into a game of Clue, another mystery game and other board games we brought. We started working on different craft projects for State Session, especially table centerpieces. We toured a number of the murals around town, then visited the Boone County Museum in town then walked to Julie's Diamond Art Store checking out more murals on the way. We had a small group of Youth, Juniors and Adults at the store, with their registration they got to pick out an \$8 diamond art painting or put the \$8 toward something larger, we also ate lunch at the store before heading back to our vehicles and picking up garbage on the sidewalk between the store and the museum as a community service project to clean up our town. We had a presentation on teen and adult internet safety that Brian Odell will be presenting at the National Grange Session two times in November. We watched the Lesson of the 1st Degree on the National Grange YouTube Channel to share that information with more people. It was originally on Zoom. Zoom has been a tool that makes it so easy to get someone from far away to help you share information with your members. We should try to make sure that our Grange Halls have internet access to make this easier for Granges to do. Our 50s theme was put to the test when we held a 50s Murder Mystery with County Line Grange providing the dinner and over 25 people in attendance to find out that Finchy killed Sandra D. A great time was had by all.

Marisa and I both attended the GRIT conference in October of last year where we had modified our list of projects after having a great first year with projects. We are excited to see what shows up at the State Session for display. We also gave each Grange a jump drive with the current information that was sent to us on it for each Grange. We asked that those drives be brought to State Session and we will return them at the GRIT conference with the new projects on them. We also hosted the Illinois State Grange Picnic at the Boone County Fairgrounds to limited attendance. We send these dates out at the GRIT conference which gives you ample time to plan to support the Youth members of our organization. The picnic is where we hand out everyone's Illinois State Grange Scholarship, please support these members by showing up and congratulating them on doing well. This year we handed out 7 scholarships to only family members and a few others. We had a vintage car show before the picnic began and those drivers also attended the picnic. Marisa and I have started planning for the coming year, I have every confidence in Marisa, but this is not easy to do alone so we will continue to work together to hopefully create a youth program that is fun, educational and meaningful for our members who will continue to be in our organization for years to come. We are also excited about our theme for next year.

I enjoyed my 4th time of being a Communications Fellow at last year's National Grange Session, we worked hard to produce content for Good Day! Magazine as well as the Patrons Chain Newsletter. I know that Lynette and I have shared them numerous times over the years, but after the first-year people didn't renew their subscription to the magazine or even though the newsletter hits their inbox they don't open the email. Do you know how much information is shared in those publications? We constantly ask what the National Grange can do for us, but never open the email, never get on the Zoom, or ignore the Facebook Live event happening now. How much better informed would your Grange be if you opened an email? We need to do better to share that information with our Granges and members. So many of our members are holding a minicomputer in their hand right now, you can share with the few members who are not as technologically advanced as you. I challenge each of you when you return home to share three things that you learned this weekend with members of your Grange who have been in your Grange for less than a year and see how interested they are in finding out more and where they can find it. Did Oliver Hudson Kelley ever dream that over 150 years later our organization would still be working hard to better our communities for everyone including farmers, ranchers, teachers, firefighters, and so many more.

Illinois State Grange Treasurer August 1, 2024

At the State Session last September, the Treasurer's position was opened after Paul Zeien elected not to retain the position. No one would step forward to take this position during the Session, which could have forced the State Grange to hire an accounting firm to manage the daily financial obligations. This was not an ideal solution, so I volunteered to take over the job and was appointed by the Executive Committee in October 2023.

Paul had worked diligently to put the finances in order and to resolve some issues that needed attention. He did a fantastic job in organizing all the accounts and establishing a thorough accounting system. This was a tremendous help to me going forward in managing the multitude of accounts that have been established over the years.

Since familiarizing myself with the many accounts handled by the Treasurer, I have been able to fine tune them a little more. Several accounts have been combined into a money market account paying better interest than checking, some have been changed to increase the interest income for the State Grange and for individual Granges whose closed Hall accounts are managed by the State Grange. Some CD's earning as little as .04% interest were renewed at much higher interest rates of 3.75% or more. This significantly increases the amount of interest being received.

Following is a summary of income and expenses for the current fiscal year, which is from September 1, 2023 to December 31, 2024 (16 months). The fiscal year was amended at the last State Session to follow the calendar year going forward so the current year included 16 months to accomplish that goal. The figures are estimates and projected through December 31, 2024.

As I expressed at the GRIT Conference on October 22, 2023, our Granges plan for the future but as Historian I look backward to highlight our Grange history. I really want to give a big Thanks to Emalee Colver, who brought me many Grange items that day for the collection. The National Grange postcards showcasing many rooms in the National Grange building back in the day are a priceless addition to our collection that I could never have imagined to have.

This year at State Session I will bring some Grange items to display and do a "show and tell" on Saturday afternoon. This year we will be celebrating 153 years!

My husband and I usually spend the winters in Florida, but this year we were Illinois bound because of my husband's health issues. I placed news articles in January, March and May issues of The Illinois Granger. Sometimes I get on a roll to think of what to write. This happens mostly when I declutter and find lots more Grange items I didn't know I had!

In November, Steve Koluch of Turkey Hill Grange sent me an e-mail requesting some information about Bob White Grange #1809 of St. Clair County. I sent him an article from April 1946 Granger when that Grange celebrated their silver anniversary. They were organized February 1921 with 44 charter members. It also had a picture of Miss Lydie M. White, oldest member at that time. She was also their first Chaplain. The article also stated that they held meetings in Union Church, which was later bought, torn down, and some of the material used in construction of the present building located southwest of Belleville on Route 158.

A few years back I visited Dorothy Newcomer of Rock River Grange#1921(Lee County). Her Grange was organized on June 19, 1951(the year I was born!). They had 50 charter members which Dorothy was one of. This year I worked on making a notebook of over 50 pages highlighting their active years. They sold popcorn, had chicken dinners, bake sales, ice cream socials, fall festivals, booster nights, to name a few. Dorothy passed away this year but I am so fortunate that she gave me this history to share. In my decluttering, I found some interesting Grange items tucked away in a briefcase. One was a business card of former National Master Kermit W. Richardson. He was elected on November 15, 1995. Then some photos of the Winnebago County Pomona Grange Degree Team in 1950 or 1952. Sometimes I have to get the magnifying glass out to make out who the people are! You know, because there are no names on the back of the photos!!

One of my best recollections of the Grange Women's Activities is the Grange Sewing Contest! All the chairmen had goals to meet. Illinois always took this very seriously! In an October 1977 Granger article Phyllis Pagles, chairman, her quota was 900 and it was surpassed with 937 entries. Many of our very talented sewers went on to win National Grange honors.

In May I attended visitation and Grange service for Boone County Granger Fay Ellwanger. At another funeral I shared some Grange Youth stories with former Grange King Bruce Cummings (1962) and his sister Virginia (Ginny). Their mother Vivian Cummings was State Ceres back in the 1960's.

WHEREAS, some Patrons are getting their mail and packages three and four months later; and WHEREAS, some Patrons have found their mail still in the post office two and three months after they took it there; and

WHEREAS, many Patrons in the rural area have lost their post offices and must travel up to twenty miles each day to get their mail; and

WHEREAS, the post office is raising the rates on postage on a continuous basis; therefore, be it RESOLVED, that the Illinois State Grange and National Grange urge the United States Postal Service to improve and reformat their services.

2024 – 07 Mileage Reimbursement Financial Committee

WHEREAS, the Illinois State Grange currently pays a mileage rate of 75% or what the IRS allows according to IRS.gov per mile round trip for all State Officers, Directors, Committee Chairmans and Committee members who attend meetings (such as State Session, GRIT, and Midwestern Leadership) request a reimbursement from the Illinois State Grange Secretary, and WHEREAS, the mileage reimbursement be paid to drive/owner of the vehicle and not to each member that carpools together, and

WHEREAS, the IRS.gov current rate is \$0.69, so at a 75% rate would be approximately \$.50 and at 100 miles, the reimbursement would be \$50 one way and \$100 roundtrip, a substantial amount more than what it is actually costing in gas and wear and tear on the vehicle. Therefore, be it RESOLVED, that the Illinois State Grange pay a mileage rate to drivers only at a rate of 75% of what the IRS allows according to IRS.gov per mile one way for all State Officers, Directors, Committee Chairman, and Committee members (such as State Session, GRIT, and Midwestern Leadership) who request reimbursement from the Illinois State Grange Secretary.

DELEGATE ACTION: Approved as amended to read

That the Illinois State Grange pay a mileage rate to drivers only at a rate of 75% of the highest rate the IRS allows according to IRS.gov per mile one way for all State Officers, Directors, Committee Chairman, and Committee members (such as State Session, GRIT, and Midwestern Leadership Conference) who request a reimbursement from the Illinois State Grange Secretary, and this will take effect on January 1, 2025.
